Memberships

Single/Couples Membership

- Open to singles or couples ages 16-64 residing at the same household address. (Children ages 10-15 qualify for participation as part of a family membership.)

Family Membership

- Three or more people residing at the same household address.
- To qualify for a family membership, children must be under the age of 18, except for college students (up to age 23 with valid student ID).

Student/Senior/Military Membership

- Student memberships are open to participants ages 10-23. (All children under the age of 18 must have parent/guardian sign membership agreement. Adult supervision is required for children ages 10-16.)
- Senior memberships are open to participants ages 65 and older.
- Military membership applies to active military and veterans and their families.

Corporate Membership

- Member's current employer or insurance company must have a corporate agreement in place with the Fitness Center at the time of payment to qualify.
- Proof of employment may be required.
- Employee must be a member to qualify other members of the household.
- Prices start out the same as standard memberships. Adjustments are made depending on details of the corporate agreement.

Aspirus Employee Membership

- Available to any employee or volunteer of the Aspirus, Inc., system.
- Employee/volunteer must be a member to qualify other members of the household.

Fee Structures

<p>A daily rate is due upon entry to the Fitness Center. Participant must have a liability waiver on file prior to exercise.</p>	<p>Open to single, couples, and family memberships where applicable.</p> <p>Activated on the day of first payment and active until the 1st of the following month (dependent upon date of initiation). Payment is expected in full at time of activation.</p> <p>Payments are due on or before the identified renewal date each month. <i>Note: Monthly memberships will automatically be renewed and new billing statements will be sent with expectation of payment by the responsible party unless the Fitness Center staff has been notified in writing of the intent to discontinue membership prior to the renewal date.</i></p> <p>Accounts may be frozen for up to a period of three months with written notice. A date for re-initiation of payment must be selected at the time the account is frozen. A fee of \$5 per month is due at the time the account is frozen.</p>	<p>Activated on the day of first payment and active until the 1st of that month of the following year. Fees can be paid in full or a monthly agreement can be signed. Electronic Funds Transfer (EFT) must be set up if choosing the monthly option.</p> <p><i>Yearly memberships automatically expire at the end of their term unless renewed by the member prior to the renewal date.</i></p>	<p>Individuals may purchase a punch card good for 10 days of Fitness Center use (with two additional days free). The card must be presented at the front desk each day of use.</p> <p>Punch cards expire six months from purchase.</p>

Punch Card (for Group Exercise Class & Gym Use):

- \$50 for 10 days (\$5/session) plus two days free – 12 sessions total

Enrollment:

- A \$10 enrollment fee applies for new monthly and yearly memberships or to re-initiate a terminated membership. New members electing automatic payment methods are eligible to waive the enrollment fee.
- On the date of initiating membership, new monthly members are responsible to cover dues from the date of enrollment until the next billing cycle, plus the first full month's dues.

Payment Options

The following forms of membership payment are accepted:

- Cash
- Check
- Credit/Debit card
- Redeemable gift certificate
- Automatic electronic funds transfer (EFT) – must provide bank account information
- Automatic credit card payment posting

Membership Termination

- All requests for cancellation of membership should be made in writing and be received by the Fitness Center prior to the member's next billing statement issuance. If notice is not received prior to the renewal date, the member may be charged renewal fees regardless of usage or payment status.
- **The Fitness Center has the right to revoke membership without fee reimbursement for members who display inappropriate or unacceptable behavior or non-compliance with terms of membership.**

Payment must be current and received prior to initiation of exercise.

Membership fees, punch card purchases, and gift certificates are non-refundable and non-transferrable.

Partial memberships (month or year) and partial punch card purchases are not permitted.

Modification of membership status (examples: changing single to couple membership or yearly to monthly membership) is allowed with written notification of Fitness Center staff prior to the renewal date of the existing agreement. Following any modification to membership eligibility or fee, current membership options will continue to be honored until the member's next billing statement is due.

Members who experience medical injuries that prohibit participation at the gym are eligible to freeze their account for the duration of the injury. A doctor's note is required to freeze the account. A doctor's note may be required for the member to return.

Non-members may trial the Fitness Center at no cost with redeemable coupon. Free day passes are available at the front desk for those who qualify. A liability waiver must be completed prior to initiating exercise.

Other discounts, open house, and/or members specials may apply.
