❖ EXECUTIVE SUMMARY

The 2010 Affordable Care Act requires that all 501(c)(3) hospitals conduct a Community Needs Assessment. The overarching view of the community assessment must be health needs from the perspective of the community, not the perspective of the health providers within the community. Community orientation is critical in this process and collaboration of efforts with other community partners to avoid duplication of efforts provides for a fiscally responsible method and valuable relationship-building process.

Every three years, NORTHSTAR Health System, in conjunction with other organizations and resources within the community, conducts a comprehensive health needs assessment. The purpose of this study is to help identify crucial health care issues affecting residents in Iron County and the surrounding communities. By using the data gathered in the Community Needs Assessment, NORTHSTAR Health System can then target services and educational programs that can help improve the health of those communities. Of note: Iron County currently is 39/82 for county health ranking and, by 2018, it is projected that Michigan will spend \$12.5 billion on healthcare related costs.

NORTHSTAR Health System has a long-standing history of working collaboratively with other health organizations to assess and address community needs. The Community Needs Assessment is a vital tool that has helped NORTHSTAR Health System determine cohorts of the population who are most at risk for various diseases. This data is then used to provide care and services through community outreach programs, preventive care measures, and education. The purpose of the report is to inform the hospital community about the health status of county residents; to identify gaps in services; and to assist in developing programs that target appropriate population sub-groups and health conditions. In keeping with NORTHSTAR Health System's mission, commitment to community and collaborative efforts to work with other community organizations; a Community Needs Assessment was conducted in May, 2013.

❖ COMMUNITY SERVED

Patient services occur through an organized and systematic process designed to ensure the delivery of safe, effective, and timely care and treatment that promotes respect and caring. The provision of patient care delivery requires specialized knowledge, judgment, and skill derived from the principles of the biological, physical, behavioral, psychosocial and medical sciences. Patient services are planned, coordinated, provided, delegated, and supervised by professional health care providers who recognize the unique physical, emotional, and spiritual (mind, body, and spirit) needs of each person. Patient care encompasses the recognition of disease and health, patient education and advocacy. At NORTHSTAR, the medical staff, nursing staff, and allied health care professionals function collaboratively as part of a multidisciplinary team to achieve positive patient outcomes.

Communities served by NORTHSTAR Health System include residents of Iron County and some outlying areas. These include zip codes of 49935, 49920, 49915, 49964, 49927, 49902, and 49903.

<p>The number of households in the United States is estimated to change from 116,716,292 to 119,206,509, resulting in an increase of 2.1% between 2010 and the current year. Over the next five years, the number of households is projected to increase by 3.5%.</p>
<p>The average household income is estimated to be \$42,701 for the current year, while the average household income for the United States is estimated to be \$69,637 for the same time frame.</p>

5.8% are in Building and Grounds Maintenance, 7.1% are in Construction and Extraction, 1.7% are in Farming, Fishing and Forestry, 3.6% are in Maintenance and Repair, 8.9% are in Production, 7.6% are in Transportation and Moving.

For the civilian employed population age 16 and over in the United States, it is estimated that they are employed in the following occupational categories: 1.8% are in Architecture and Engineering, 1.9% are in Arts, Entertainment and Sports, 4.7% are in Business and Financial Operations, 2.5% are in Computers and Mathematics, 6.1% are in Education, Training and Libraries, 5.4% are Healthcare Practitioners and Technicians, 2.5% are in Healthcare Support, 0.9% are in Life, Physical and Social Sciences, 9.7% are in Management, 14.0% are in Office and Administrative Support.

1.7% are in Community and Social Services, 5.6% are in Food Preparation and Serving, 1.2% are in Legal Services, 2.2% are in Protective Services, 11.1% are in Sales and Related Services, 3.5% are in Personal Care Services.

4.0% are in Building and Grounds Maintenance, 5.3% are in Construction and Extraction, 0.7% are in Farming, Fishing and Forestry, 3.3% are in Maintenance and Repair, 6.0% are in Production, 6.0% are in Transportation and Moving.

Currently, it is estimated that 3.7% of the population age 25 and over in Iron County had earned a Master's Degree, 1.2% had earned a Professional School Degree, 0.4% had earned a Doctorate Degree and 9.7% had earned a Bachelor's Degree.

In comparison, for the United States, it is estimated that for the population over age 25, 7.3% had earned a Master's Degree, 1.9% had earned a Professional School Degree, 1.2% had earned a Doctorate Degree and 17.7% had earned a Bachelor's Degree.

Most of the dwellings in Iron County (81.8%) are estimated to be Owner-Occupied for the current year, 2013. For the entire country the majority of the housing units are Owner-Occupied (65.0%).

The majority of dwellings in Iron County (86.5%) are estimated to be structures of 1 Unit Detached for the current year. The majority of dwellings in the United States (61.5%) are estimated to be structures of 1 Unit Detached for the same year.

The majority of housing units in Iron County (34.6%) are estimated to have been Housing Unit Built 1939 or Earlier for the current year.

The majority of housing units in the United States (16.1%) are estimated to have been Housing Unit Built 1970 to 1979 for the current year.

❖ RESPONDING RESOURCES

❖ GATHERING DATA

Data collection provided the foundation to understanding the needs of the community and determining how priorities would be set. Primary data was gathered through a community online survey made available to Iron and Dickinson County community members. The survey was conducted in cooperation with NORTHSTAR Health System, Department of Human Services, Dickinson County Healthcare System, Dickinson Iron Community Service Agency, Dickinson Iron District Health Department, Great Lakes Recovery Centers, Inc., Great Start Collaborative, Kiwanis/Rotary, West Iron County Public Schools, Forest Park Public Schools, Medical Care Access Coalition, Michigan State University Extension, Northpointe Behavioral Healthcare System, and the Office of Veteran Affairs.

A secondary source of data collection included a series of focus group meetings led by NORTHSTAR's Director of Community Services. The groups ranged in size from 8 to 12 people and key individuals in the community were identified to participate to assure that appropriate constituencies were represented.

Ethnicities, race and other diversity factors were included in the selection of these focus groups. These focus groups had a facilitator assigned who was skilled at creating and maintaining an environment where every participant's voice was heard and where a single individual or topic did not dominate.

Secondary data, statistics available for the assessment available from other community sources, were used. This data came from both state and local agencies as well as other organizations. These included census and demographic data, health incident data, and market assessments.

❖ HEALTH NEEDS OF THE COMMUNITY

The purpose of the Community Needs Assessment was to report to the community about the health status and concerns of county residents and to identify gaps in services and to assist in education and developing programs to bridge those gaps. As a result of the survey process, several areas of concern were identified and will be followed with strategic initiatives to provide education or services to meet those identified needs.

NORTHSTAR Health System has a long tradition of caring for those in need, regardless of their ability to pay, healing the sick, and serving as stewards of the communities. In the past decade, NORTHSTAR's role has expanded; no longer simply treating illness, but also seeking to improve and maintain the overall health of patients and community residents. The heart of NORTHSTAR Health System's mission is to serve our communities by improving health. The Vision Statement of NORTHSTAR Health System is *"The People We Serve Will Be Among the Healthiest In The Nation."*

❖ HEALTH NEEDS IDENTIFIED

Once the survey was completed, the assessment team evaluated the priority items identified, took an inventory of available resources, assessed the overall adequacy of the services, the integration of these services into the community, and the needed improvements or gaps in care. Some of the items identified on the survey which fell below the 15 percentile were not followed up with a strategic initiative by NORTHSTAR Health System. Most of these items (child abuse/neglect, domestic violence, firearm related injuries, motor vehicle crash/injury, rape/sexual assault) were designated for more appropriate follow up with local law enforcement agencies and/or family service agencies. The following concerns were flagged as priorities for follow-up strategic planning:

SUBSTANCE/ALCOHOL ABUSE

In the past decade, substance abuse has been repeatedly identified as a community health priority. Alcohol and other drug abuse, including the abuse of prescription drugs, and smoking have consistently ranked at the top of identified community health concerns. This abuse has a significant social and economic impact on the residents of Iron County. It has been estimated that this abuse has a tremendous economic impact in lowered productivity, health care and criminal justice systems costs, injury and premature death.

OBESITY/CHILDHOOD OBESITY

Overweight and obesity are defined as abnormal or excessive fat accumulation that may impair health. More than one-third of U.S. adults and 16% of U.S. children are obese. Since 1980, obesity rates for adults have doubled and rates for children have tripled. Michigan ranks 5th for obesity in the nation with a 31.3% adult obesity rate. 70% of Iron County elementary school children qualify for free or reduced lunch – the national indicator for economically disadvantaged. Research has shown that as weight increases to reach levels of overweight and obesity, the risks for coronary heart disease, type 2 diabetes, cancer, hypertension, cholesterol, stroke, liver and gallbladder disease, sleep apnea and respiratory problems, osteoarthritis and infertility also increases. The survey identified that change initiatives to make healthy choices in nutrition and physical activity will likely prove effective in combating obesity.

MENTAL HEALTH

Mental health has been defined as a state of “successful performance of mental function resulting in productive activities, fulfilling relationships with other people, and the ability to adapt to change and cope with adversity.” Mental disorders are characterized by “alterations in thinking, mood, or behavior associated with distress and/or impaired functioning.” Mental disorders are the leading cause of disability in the U.S. Mental health and mental illness can both cause and be influenced by positive or negative social determinants of health, which include income, housing, stress, early childhood experiences, social exclusion, occupation, education level, social support and lack of access to resources. Recent studies suggest that primary care settings provide a unique opportunity for early detection and treatment of common mental disorders by identifying early warning signs and mitigating risk factors.

CANCER

Cancer is a large group of diseases in which abnormal cells divide uncontrollably. Every year cancer kills half a million Americans. Cancer is the second leading cause of death in the U.S., exceeded only by heart disease. While identified on the survey, the number of new cancer cases can be reduced, and many cancer deaths can be prevented. A person’s cancer risk can be reduced by receiving regular medical care, avoiding tobacco, limiting alcohol use, avoiding excessive exposure to ultraviolet rays, eating a diet rich in fruits and vegetables, maintaining a healthy weight, and being physically active. Adequate access to cancer screening and the availability of high-quality treatment among poor and underserved populations are critical to reducing the burden of cancer.


FOOD AND NUTRITION

Fruits and vegetables – as part of a healthy diet – are important for optimal child growth, weight management, and chronic disease prevention. Numerous studies have shown that diets rich in fruits and vegetables are associated with reduced risk of several chronic diseases including heart disease, stroke, some cancers, diabetes and osteoporosis. There is a large gap between recommended dietary patterns and actual consumption by persons of all ages. Fast food contributes to adverse health consequences like obesity. Research has shown that people make food choices based not only on personal preference but environmental factors such as food access, availability and affordability. Studies have shown that among poor and underserved populations, the consumption of fast food outweighs healthy nutritional choices by a sizable margin.

❖ COMMUNITY FEEDBACK

Following analysis and interpretation of community feedback, a task force was established to develop an implementation strategy.

❖ COMMUNITY TASK FORCE
