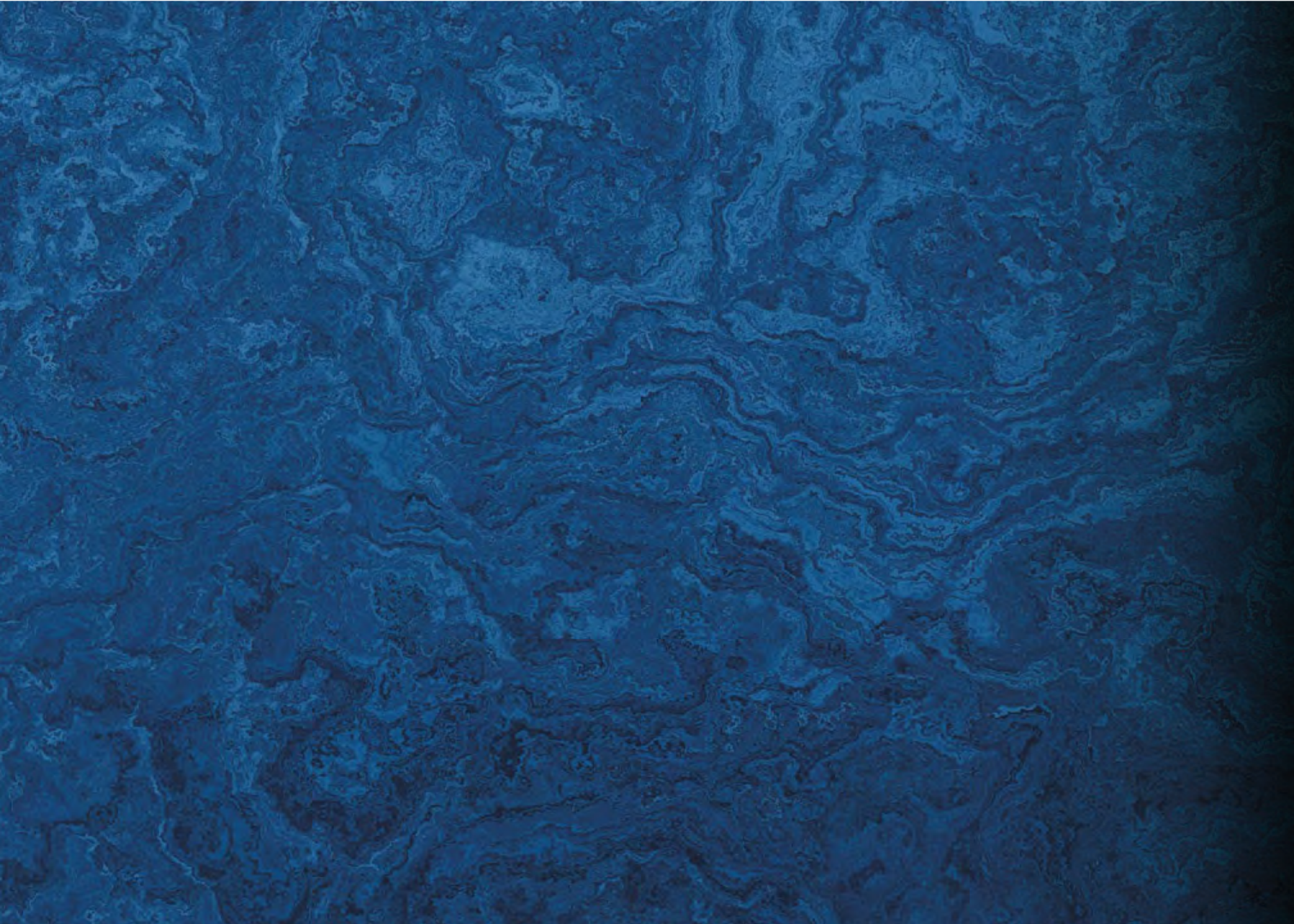

Each one of you has a unique story of why you support the Foundation. Together, the collective story of your kindness and its impact is felt in every aspect of the care we provide.



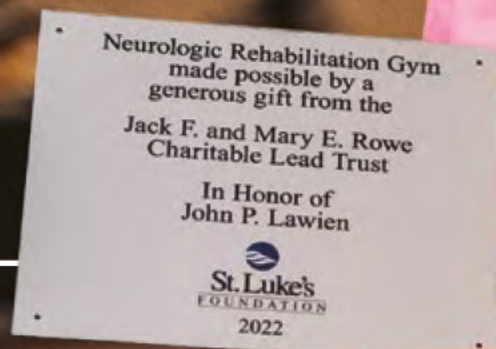

# The Incredible Comeback

Generous gifts during Circle of Light Gala supported the relocation and expansion of St. Luke's Rehabilitation Services and the creation of St. Luke's Neurologic (Neuro) Rehabilitation Gym.

I want to make sure no other family member has to go through what I went through," says Lizette Lawien.

It was 1985, and Lizette's husband, John Lawien, was transferred out of St. Luke's after being treated for a traumatic brain injury (TBI). He needed neurological rehab, but at that time St. Luke's didn't offer it. Lizette had to admit John to a new healthcare system and care team. "It was one of the worst days of my life," she recalls.

That day stayed with her. St. Luke's has grown its program through the years, and when the chance to support a new comprehensive neuro rehab gym was presented to Lizette, she eagerly jumped on board. As part of the Circle of Light event, Lizette donated \$50,000 to the gym, in honor of her husband.

Her gift comes from the *Jack F. and Mary E. Rowe Charitable Lead Trust*, established by and in her parents' names. As trustee, Lizette supports efforts and priorities that advance care and education in our community.

Lizette's gift, along with the gifts of many others, made the 2022 Circle of Light gala – "The Incredible Comeback" – St. Luke's Foundation's

most successful ever. The generous outpouring created more than St. Luke's Neurologic Rehabilitation Gym. It helped support the expansion and relocation of St. Luke's Rehabilitation Services and provide the resources to inspire our patients' stories to continue despite challenges.

Along with the Rehab Gym, all three rehab disciplines – physical, occupational and speech therapy – are now located in the former Emergency Department space. "Having this space not only allows for expanded services, but also greater collaboration," says Brett Osborne, Director of Rehab Services.

"The support of donors, like Lizette, gives our highly skilled clinicians the tools and space to take treatments to the next level and make sure we never turn a patient away because we don't have the right equipment," says Eva Trueblood-Pearce, Supervisor of Rehab Services.

Because of Lizette's gift, patients and caregivers will not have to endure the stress of moving hospitals, as she and John did.

"My joy is seeing how the gift is used," she says. "It benefits patients, their families, the providers, and the whole community."

# Upon Awakening



## Waking up from anesthesia after surgery can be very disorienting.

For many, the sensory and physical sensations are frightening and uncomfortable.

"It's a very vulnerable time in a patient's stay," says Shannon Cummings, RN, Clinical Supervisor of St. Luke's Post Anesthesia Care Unit (PACU). "They're completely reliant on us to make sure they're safe."

With a St. Luke's Foundation grant, Shannon and the PACU team – particularly colleagues Amber Peterson, RN, BSN, and Megan Forsyth, RN, BSN, MBA – implemented the Patient Surgical Experience Comfort Improvement Project. This project aims to enhance patients' experience.

A portion of the grant funded light diffusers with open sky views plus large pictures of serene natural scenes by Grand Marais Photographer Bryan Hansel.

Patients often relate to the images, even recognizing them from past experiences. Focusing on the scenes and pleasant memories helps reduce anxiety and creates a sense of tranquility.

Patients are also now offered a "comfort menu," featuring several items, from lip moisturizer to aromatherapy.

"The grant allows us to increase our offerings. It's also made our space calmer," says Amber. "We want patients to know we're here to do everything we can to help them feel more comfortable and safe."

# Our Hearts Cannot Wait

Much of the world came to a halt in the early weeks and months of COVID-19. But for people suffering urgent cardiac needs, delaying care could have been fatal.

"We demonstrated that even in the severe, unprecedented time of the pandemic, St. Luke's was able to continue providing high quality care for these patients who had a higher risk of complications or death if they didn't get care," says Cardiothoracic Surgeon Dr. Mary J. Boylan.

A grant from St. Luke's Foundation is helping Dr. Boylan and her team, including University of Minnesota Medical School students, investigate the impact of COVID-19 on cardiac patients. The ongoing project also looks at how to best serve the community's ongoing health needs, a focus of the Foundation.

The students presented the initial findings at a recent medical school symposium and will continue to assist with ongoing analysis.

The gift honors Bob's life in many ways.

"Bob and I have always felt good about giving to St. Luke's Foundation because we know the money stays right in our community," says Helga. "It was also meaningful to give to an area of St. Luke's where our daughter works. It's such a good feeling to know Marcy can actually see every day how this memorial gift is helping people."

Marcy agrees. "I know EMS providers really appreciate having this space to decompress. They work so hard for the community, it's important for them to know we want to take care of them, too."

This designated space also helps connect EMS with the rest of the team, resulting in better care all around. "The ED docs always appreciate the chance to connect and to talk about patient care," says Marcy. "It's good to follow up and it helps build rapport, which is important."

Today, Bob's story lives on through this memorial gift. "I'm so grateful we can honor Bob's memory this way," says Helga.

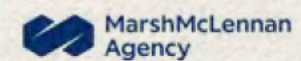
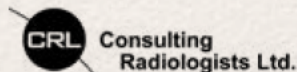
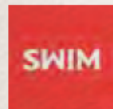

Words of inspiration, energy and support are woven into the very fabric of the pillows Louise Pell makes for patients undergoing breast surgery at St. Luke's.


A dedicated volunteer, Louise's sewing efforts started as a way to be of service during the pandemic. That's when she sewed and donated more than 5,000 masks to St. Luke's. Now, her efforts have evolved to sewing breast surgery comfort pillows and "port pillows" that fit around a seatbelt and cushions the portacath where chemotherapy is placed into the patient's chest.

The project brings her back to her love of sewing, a chapter of her life that had been put on hold for many years. She credits the work for keeping her grounded and giving her a sense of purpose. "It's brought me a lot of gratification to make somebody else's life just a little better. And to maybe give them a little bit of extra comfort knowing someone made the pillow – with love – just for them."

Louise delivers a new batch of pillows to the Foundation weekly. Though she has not yet met a recipient, just knowing people benefit from her creations gives her great joy.

"I wish there wasn't a need for the pillows," she says, "but since there is, I will keep making them."

# Supporting Every Provider in a Patient's Journey

St. Luke's Trauma Services use grant-funded tools to educate providers throughout the region.

Jane Smalley, Manager of St. Luke's Trauma Services, is passionate about teaching everyone who cares for severely injured patients.

"I want our patients to receive the best care, which means ensuring everyone who takes care of them knows as much as they can."

A grant from St. Luke's Foundation's *Willey H. Mitchell Fund* supports Jane's passion to teach Advanced Trauma Life Support (ATLS) class to physicians, nurse practitioners, physician assistants, and family practice residents at St. Luke's and at rural clinics throughout the region.

The class gives providers crucial hands-on skills in assessment, treatment, and procedures needed to care for a severely injured trauma patient. In the class, they practice chest tube placement and advanced airway procedures. "Providers need these skills to transport the patient safely, especially during a three-hour ambulance ride or via helicopter," she says.

ATLS training is required for providers every four years. Because the volume of patients in rural settings is naturally lower, this training may

be the only time providers practice the skills needed to treat severe trauma. Jane recognized a need for more frequent refresher trainings and wanted to support providers so they feel competent and confident treating severe injuries.

The grant funds simulation manikins that Jane uses to teach ATLS to St. Luke's providers and all family practice residents in the area. She also transports them to providers in rural settings, teaching these vital skills throughout the region.

"I have a passion for rural care, especially for those who are out there with very little backup. They are the first line of defense," says Jane.

For patients, the care they receive before arriving at the Emergency Department is the first step in their story of survival.

"More skilled care in the field results in better outcomes," says Jane. "When you see it work, it's amazing. People survived because everybody involved knew what they were doing and did it well."

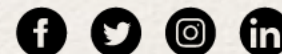
